The processing carried out does not envisage the use of automated decision-making processes.

### Legal basis of the processing

The processing is carried out on the basis of the existence of legitimate interest as there is a relevant and appropriate relationship between the Data subject and the Data controller (contractual relationship).

### Provision of data

The provision of data is optional, but necessary for the achievement of the purposes mentioned above and the unavailability of the same does not allow the fulfillment of the above obligations or the administrative and accounting management of the relationship.

### Data communication - Dissemination – Transfer
